If awarded the contract, Bidder agrees to schedule and execute the Work in accordance with the Master Project Schedule to be developed, maintained and updated by the University Representative. Bidder agrees to fully complete the Work within the Contract Time.

The daily rate shown above will be the total amount of Contractor entitlement for each day of Compensable Delay caused by University at any time during the performance of the Work and shall constitute payment in full for all delay costs, direct or indirect (including, without limitation, compensation for all extended home office overhead and extended general conditions), of the Contractor and all subcontractors, suppliers, persons, and entities under or claiming through Contractor on the Project. The number of days of Compensable Delay shown as a "multiplier" above is not intended as an estimate of the number of days of Compensable Delay anticipated by the University. The University will pay the daily rate of compensation only for the actual number of days of Compensable Delay, as defined in the General Conditions; the actual number of days of Compensable Delay may be greater or lesser than the "multiplier" shown above.

7.0 SELECTION OF APPARENT LOW BIDDER

To determine the low Bidder, University will calculate for each bidder an amount which will equal the sum of the Lump Sum Base Bid (Item 4.0 above) plus Unit Prices multiplied by the respective estimated quantity listed (Item 5.0 above), plus the amount of daily rate for compensable delays multiplied by the "multiplier" listed (Item 6.0 above), plus the amount of all Alternates selected (Item 8.0 below). The Contract will then be awarded to the Bidder submitting the lowest amount so calculated), or else all bids will be rejected. The Contract Sum will be the sum of the Lump Sum Base Bid and the additive or deductive amounts for each accepted Alternate.

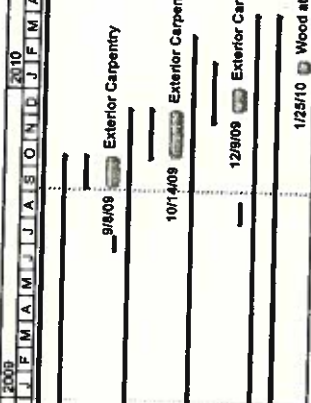
